Purple Run For A Cure (PRFC) TERMS AND CONDITIONS: 1) Vendors shall submit the required fee with application by March 28th, 2019 2) Town permits must be received 30 days before event.. It is your responsibility to submit in timely manner to town. . 3) Load-In times: Sunday morning from 6am to 10am. No vehicles allowed on the field after the appointed time. 4) Due to increased security measures never leave your vehicle unattended at any time while within the venue. Do not leave backpacks, packages, boxes, bags unattended outside your booth at any time. Vendors are responsible for their own merchandise. PRFC assumes no liability for theft or loss of any type. 5) Vendors are required to be open on Sunday, April 28th from 10am - 2:00 pm. If crowd supports it, Vendors may remain open until 3pm, but no later. CLOSING BEFORE END OF EVENT, OR STAYING OPEN AFTER END (or 3pm) OF EVENT IS GROUNDS FOR EXCLUSION FROM PARTICIPATION AT FUTURE EVENTS. 6) All business or other activity, for which the vendors have rented space, must be conducted within the designated and outlined booth space only! Vendor signage can be displayed ONLY WITHIN EACH BOOTH. 7) Wineries are prohibited from selling food, water or drinks of any type on festival grounds. 8) Consumption of alcoholic beverages by vendors at their booth is prohibited. 10) Vendors must provide trash receptacles for waste generated by their site. A deposit of \$50 for cleanup, is due upon accepting this agreement. 9) PERMITS: You are required to obtain and display all necessary permits and/or licenses in order to operate on the festival grounds. If you are forced to close by any government agency for failure to obtain your necessary permits and/or license, The PRFC or its agents are not liable and will not refund any fees or deposits. 12) Sites may not be shared by multiple businesses. Vendor agrees to all TERMS AND CONDITIONS provided with this application. Each booth will be inspected during event and violators of any of the terms and conditions will forfeit booth space, and deposit fee and will not be invited to return to future events. 13) REFUNDS: Your booth fee is NON-REFUNDABLE unless cancellation, IN WRITING, is received before March 25th, 2019. If event is canceled for any reason up to the deadline, a refund will be made within 45 days of cancellation. 15) Submission of this application does not guarantee a space. It is agreed and understood that the completion of this application shall not be binding either to the proposed vendor or to the PRFC, until accepted by the PRFC.
